2	North Texas RCI Chapter Financial Update	 Bill presented information regarding the 2016 financial status of the chapter (See attached). Information related to specific events is described in Items 3 and 4 of these meeting minutes. As of August 26, the 2016 net income is \$14,852.20 Bill completed an analysis of the chapter finances (present and past years) and has successfully balanced the checkbook.
3	2016 Golf Tournament Financial Update	 Bill provided the board with a financial update for the upcoming annual golf tournament (see attached spreadsheet) Current projections estimate a profit of approximately \$9,400. The event is now full and we will no longer be accepting any additional teams.
4	Top Golf Event Financial Review	 Bill provided the board with a financial review of our Top Golf event held this past May (see attached). The event netted a loss of \$986.43 The board discussed revisions for next year to include increased promotion leading up to the event and cancelling the monthly lunch and learn that falls in the same month, to

A motion was made for 2017 to cancel the monthly lunch and learn events that fall in the same month as the Top Golf event and the Golf Tournament. The motion was seconded, the board voted, and the motion passed.
5	Treasurer Board Position	 Bill expressed a desire to remain the chapter treasurer going forward to help provide continuity and stability to the chapter finances. The board discussed the previous challenges that the treasurer position experiences which arise from the one year turn over. Removing the treasurer position from the presidential succession plan to a director position would accomplish this effort. Two motions were made. 1) To allow Bill to remain the treasurer for next year and 2) To remove the treasurer position from the presidential succession plan and revise the chapter bylaws and guidelines to reflect this change for the following year. The motions were seconded, the board voted, and the motions passed. Action Items: Bryan to review the chapter bylaws and guidelines
		and determine the changes that need to be made to reflect the motions that were passed. Bryan will submit the necessary changes to the board president (David) for review.
6	Membership list	 The board discussed the current membership list. It was determined that Paul has the most up to date list of members and attendees.
